Use of ambulance transport without Nevada permit; exemptions.

Nevada hospitals treating victims of Mandalay Bay shooting, 2017

This bulletin is to notify hospitals within the State of Nevada of the current laws regarding the use of out-of-state ground and air ambulance agencies.

Any agency that engages in the operation of ambulance services within the State of Nevada is prohibited from doing so unless they have been issued a permit from the Nevada Division of Public and Behavioral Health or Southern Nevada Health District Office of Emergency Medical Services & Trauma System.

In response to the mass shooting that occurred at Mandalay Bay on October 2, 2017, the Division may authorize a temporary exemption for an out-of-state agency to transport a victim of the mass shooting.

Hospitals should make all reasonable attempts to secure transport utilizing a permitted agency within the State of Nevada. A list of permitted agencies is included and may be obtained by clicking here. If all reasonable attempts have failed, or if transport by an out-of-state agency is requested by the patient, patient's family, or ordered by the patient's physician, then the hospital may request a temporary exemption.

To request a temporary exemption, the hospital must provide the Division with the following:

- A written request to utilize an out-of-state agency, including:
 - O Statement verifying the patient being transferred is a victim of the mass shooting;
 - o Statement verifying all reasonable attempts were made to utilize a permitted agency, OR this was a direct request of the patient, patient's family, or physician-ordered;
 - o The name, address, and phone number of the out-of-state agency;
- A copy of the agency's permit to operate, issued by their health authority or jurisdiction.

The Division will verify all information submitted, then issue a letter of exemption, for each patient, to the hospital. Once the letter of exemption has been received, the hospital has the authority to execute the transfer.
