Topic: Updated Guidance: What to do when Exposed to COVID-19

Background

The Centers for Disease Control and Prevention (CDC) updated their guidance August 24, 2022, for persons who have been exposed to COVID-19.¹ If an individual was exposed to the virus that causes COVID-19 or has been told by a health care provider or public health authority that they were exposed, the following are the recommended steps that should be taken, regardless of vaccination status or if the individual had a previous infection.

After Being Exposed to COVID-19

The following guidance applies for the general public.

Start precautions *immediately* — The exposed individual should wear a <u>mask</u> as soon as they find out they were exposed and should continue to wear a mask for 10 full days when around others.

Start counting from Day 1.

- Day 0 is the day of their last exposure to someone with COVID-19.
- Day 1 is the first full day after the individuals last exposure.

Continue precautions for 10 full days — An exposed individual can still develop COVID-19 up to 10 days after they were exposed.

Take precautions

- A high-quality <u>mask</u> or respirator (e.g., N95) should be worn any time around others inside their home or indoors in public.
 - An exposed individual should not go places where a mask cannot be worn. For travel guidance, see CDC's <u>travel</u> webpage.
 - Masks are not recommended for children 2 years and younger, or for people with certain disabilities. Other prevention actions (such as improving ventilation) should be used to avoid transmission during these 10 days.
- Extra precautions should be taken when around people who are more likely to get very sick from COVID-19.

Watch for symptoms

- Fever of 100.4°F or greater
- Cough
- Shortness of breath
- Other COVID-19 symptoms

If an exposed individual develops symptoms

Isolate immediately

- Get tested
- Stay home until the results are received. If your test result is positive, follow the <u>isolation</u> recommendations.

Get tested on day 6 — An individual exposed to COVID-19 should get tested at least 5 full days after their last exposure even if symptoms do not develop. If a person has already had COVID-19 within the past 90 days, see specific testing recommendations.

If the exposed individual tests negative

- Continue taking precautions through day 10.
- Wear a high-quality mask when around others at home or indoors in public.

Individuals can still develop COVID-19 up to 10 days after they were exposed.

If the exposed individual tests positive

- Isolate immediately.
- Follow the guidelines in our recent technical bulletin, <u>Updated Guidance</u>: <u>Isolation and</u> <u>Precautions for People with COVID-19</u>.

Learn how COVID-19 spreads and the <u>factors that make risk of spread higher or lower</u>. Nevada's call center (800) 401-0946 is open 7 days a week from 7 a.m. to 8 p.m. to speak to a person regarding COVID-19 vaccinations, treatment and therapeutic services.

As noted in the Food and Drug Administration labeling for authorized over-the-counter antigen tests, negative test results do not rule out SARS-CoV-2 infection and should not be used as the sole basis for treatment or patient management decisions, including infection control decisions.

Reporting of Possible Cases

COVID-19 laboratory results must be reported as outlined in the <u>Updates to COVID-19 Laboratory Reporting</u> Requirements technical bulletin (dated March 25, 2022). Contact the appropriate health authority to report.
